### FRESH START TO THE YEAR: SELF CARE RETREAT

he Children's Advocacy Center started the year off by escaping the modern stresses of life and a Monday morning by engaging in a self-care retreat. Our CEO Caroline Vinyard in partnership with Harmony Hopes Stables, treated the multidisciplinary team (MDT) to a holistic approach to relaxation. MDT members received self-care healing through Sound Vibration Therapy, music, nature, equine psychoeducation, and goat walking. MDT members in attendance included: Law enforcement from Martin County Sheriff's Office Special Victims Unit and the Indian River County Sheriff's office, Victims' advocates from the Sexual Assault Assistance Program, Child Protective Investigators from the Children's Advocacy Center Unit and Children's Advocacy Staff. Self-care for professionals is vital to the effectiveness of the services provided to abuse victims. Helping professionals often don't consider their own needs or are preoccupied with their responsibilities. Helpers mistakenly believe they are invulnerable to fatigue, stress, frustration, and depression. Often, they see the needs of others and feel the responsibility to lift them, and in the process, they forget about self-care. As helping professionals, we have learned that helpers also need help, encouragement, and support. Being successful in the human services field requires a



strong, committed individual. It is essential to respond to multiple needs, often in a crisis for the individual or family. Every youth/family is different, and providing a nurturing response requires a level-headed and capable professional. The CAC will offer self-care and team building activities at least 1x per month.



# CHILD PROTECTION TEAM



he Child Protection Team under the umbrella of Children's Home Society is a partner agency housed at the Children's Advocacy Center. When children have experienced abuse or neglect, the Child Protection Team helps them through the journey toward healing.

The Child Protection Team serves the entire family. While the focus is on the child's health, safety and emotional well-being, they also understand that the healing process involves the whole family. The team is sensitive to children's physical and emotional pain and works closely with local officials to help ensure children's safety and to connect them with appropriate services as they work through their trauma.

The Child Protection Team provides services and support for children who have experience abuse or neglect, including:



- Medical diagnosis and evaluation
- Child and family psychosocial assessments
- Psychological evaluations
- Specialized and forensic interviews
- Expert court testimony

#### **CAC Services**



#### **Mental Health**

We offer trauma-informed, evidence-based mental health care as a specialized clinical process designed to assess and mitigate the long-term adverse impacts of trauma or other diagnosable mental health conditions. Our licensed mental health counselors provide individual and family therapy to both children and adults via telehealth and office visits.



#### Prevention

Our Prevention Education Program is currently being proposed in all four counties within Circuit 19. Our program aims to educate and empower children and adults with information and strategies to prevent, recognize, and respond appropriately to child abuse, digital dangers, and trafficking using evidence-based curricula in after-school programs and youth-serving organizations.



#### **Supervised Visitation & Monitored Child Exchange**

The CAC offers supervised visitation and monitored child exchange as requested by the family court system. Our visitation goals are to support healthy communication between parents and children.



#### **Advocacy Case Management**

Our CAC coordinator provides advocacy case management services to children and their nonoffending caregivers presenting at the CAC. This direct service provision includes interpretation services, crisis counseling, needs assessment, transportation, emergency supplies, and multidisciplinary team staffing.
